Now, as Taylor fully knows, when I am done with someone, due to trust issues or them stabbing me in the back, as I am my own person, I am done with them for good. I don't care if it's 20yrs later. I will still feel the same way.

That is what happened.

Then, Taylor decided to throw a fit and went back into our private chat log and cherry picked things that we have privately discussed which in all reality is no one's business as there was an expectation of privacy.

She went to the trolls and to her followers to profess these lies as well as put me, my family and a good friend at future risk of harassment or worse. If you have ever been on her platforms, it's really easy to see her pattern is systemic.

I received a death threat and I filed a police report with her information on it as she was the catalyst to it and if anything happens further than internet trolling, she will be liable for any future incidents as now I have created a paper trail.
